RELEASE AND WAIVER OF LIABILITY

PLEASE READ CAREFULLY! THIS IS A LEGAL DOCUMENT THAT AFFECTS YOUR LEGAL RIGHTS!

This Release and Waiver of Liability (the "Release") executed on this ____ day of _____, 20____, by

____ (the "Player") in favor of Habitat for Humanity International, Inc., a non-profit corporation, and the Greater Erie Area Habitat for Humanity, a Pennsylvania non-profit corporation, their directors, officers, employees, and agents (collectively, "Habitat"). The Player desires to compete in the "Habitat Hat" Ultimate Frisbee Tournament and engage in the activities related to being a player (the "Activities"). The Player understands that the Activities may include playing in Ultimate Frisbee games and otherwise being on the fields and premises of the "Habitat Hat" tournament.

The Players hereby freely, voluntarily, and without duress executes this Release under the following terms:

Release and Waiver. Player does hereby release and forever discharge and hold harmless Habitat, **event sponsors and event facility and their successors** and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Player's Activities with Habitat.

Player understands that this Release discharges Habitat, **the event sponsors and the event facility** from any liability or claim that the Player may have against Habitat, **the event sponsors and the event facility** with respect to any bodily injury, personal injury, death, or property damage that may result from Player's Activities with Habitat, whether caused by the negligence of Habitat or its officers, directors, employees, or agents or otherwise **or the event facility officers, directors, employees, or agents or otherwise**. Player also understands that Habitat, **the event sponsors or event facility** does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but no limited to medical, health, or disability insurance in the event of injury or illness.

Medical Treatment. Player does hereby release and forever discharge Habitat, **event sponsors and event facility** from and claim whatsoever which arises or may hereafter arise on account of any first aid treatment, or service rendered in connection with the Player's Activities with Habitat.

Assumption of the Risk. The Player understands that the Activities include competitive game play that may be hazardous to the Player and transportation to and from the "Habitat Hat" tournament premises. Player hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases Habitat, **event sponsors and event facility** from all liability for injury, illness, death, or property damage resulting from Activities. **Each Player is expected and encouraged to obtain his or her own medical or health insurance coverage.**

Photographic Release. Player does hereby grant and convey unto Habitat all right, title, and interest in any and all photographic images and video or audio recordings made for Habitat during the Player's Activities with Habitat, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographers or recordings.

Other. Player expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Pennsylvania, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Pennsylvania. Player agrees that in the event that any clause or provision of the Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.

Misconduct of a sexual nature within the organization interferes with its moral mission and will not be tolerated. Greater Erie Area Habitat for Humanity seeks to create an environment of hospitality for all persons, male or female, which is free of misconduct of a sexual nature and encourages respect, equality and kinship in Christ.
